Rain Barrels

Capturing rainwater helps the environment and reduces use of more expensive water. Rain Barrels store rainwater redirected from your gutters into a container that can be used to water plants and gardens.

Foothill MWD through the Foothill Family of Water Agencies is offering a rebate of 50% of the cost of a rain barrel up to \$100. There is a limit of 2 barrels per downspout with a maximum of 8 barrels per property.

PROGRAM ENDS JUNE 30, 2012 or when funds are depleted.

Rain Barrel Rebate Application Process

Eligibility:

Any property owner (resident, institution or business) in the Foothill service area and any tenant of that property with the permission of the owner may apply for a Rebate that is a water service customer of a Foothill retail agency.

Should applicant receive funding, the following must be complied with:

1. Rain barrel must be maintained in working condition and use collected water for irrigation for three years from receipt of funding.
2. Rain barrels must have vector (mosquito, rodent) control.
3. Rain barrels must be placed on a solid foundation for stability and be elevated at least 6 inches to allow for gravity flow of water.
4. Rain barrels must be strapped to the wall for earthquake safety.
5. Rain barrels must not block or restrict access around the home or property for emergency purposes.
6. Upon prior notification to customer, allow water agency staff access to property for photo-documentation and other data gathering purposes.
7. Allow FMWD and other retail agencies to reference the project in outreach materials.
8. Provide FMWD and retail agency appropriate information about the project for the purposes of program reporting and disbursement of funds.

Rebate Application Process:

1. Submit:

Upon completion of the project, submit expense receipts and schedule an inspection by calling your retail water provider. The provider's name and a contact number can be found on your last water invoice.

2. Inspection:

- a. Verification that rain barrel(s) listed on receipts are installed.
- b. Verification that rain barrel(s) are installed per the program requirements.
- c. Photos of all rain barrel(s) to be rebated.

3. Rebate Check:

- a. Upon final approval and submittal of receipts, a rebate check will be issued within 4-6 weeks from your water provider.
